EVT REPORT:

CAPTAIN'S REPORT:

- Captain Stimits discussed part-time hours, call volume and specifics on three calls the crews ran during the last month.
- Captain Stimits stated a picture of the Engine was displayed in the BME calendar.

DEPUTY CHIEF'S REPORT:

- Deputy Chief Rial discussed new camera system for zoom meetings. South Central Region purchased the system for the department. A big thank you to Firefighter / Paramedic Drew Maurer and Firefighter / EVT Johnsen for their work in setting the new system up.
- Deputy Chief Rial discussed the Engineer promotional process held today. Roy McMurtry & Greg Bodine were the two candidates. Congratulations to Greg Bodine for his promotion to Engineer.
- Deputy Chief Rial discussed the application process for the open fire fighter position. The department will hire one new person by the end of February with a start date in early March.

- Deputy Chief Rial discussed training hours. Deputy Chief Rial discussed training to include DJ from Common Spirit trained A shift on Airways, Overview of 2025 EMS and Fire Training schedule, firefighter training covered SCBA's and Donning Bunker Gear, Engineer training covered Winter Driving and Pumps Ops, Captains training covered the first 5 minutes of and incident. Cadre training will cover EV Blanket Deployment.
- Deputy Chief Rial stated the department has completed seventeen policies and two procedures.
- Deputy Chief Rial stated that Captain Stimits has developed a new employee evaluation form which will be sent out next week and due by February 28, 2025.
- Deputy Chief Rial discussed the Christmas party on December 6th. Awards were awarded to Part-Time Firefighter of the Year, Karen Bodine, Firefighter of the Year, James Wells, and the Chief's Award to Jonas Johnsen. The department also recognized the staff for milestones of years with the department.

CHIEF'S REPORT:

- Chief Lambert discussed the possibility of purchasing mechanics service vehicle from Teller County. This truck is already set up with a compressor and box for tools. Teller County has asked the department to make an offer based on reasonable value.
- Chief Lambert stated that he has contacted three companies to give us a quote on Impact Fee Study for the district.
- Chief Lambert stated Colorado Springs Fire Department conducted 73 Inspections in 2024.
- Chief Lambert updated the BOD on the status on the Congressional Direct Spending grant for the training tower and stated we should get an answer by the end of March.
- Chief Lambert discussed the expense of charging an electric car or diesel engines at the station. The department can implement a policy if needed.
- Chief Lambert discussed the departments Active 911 paging system. We may upgrade of the system to Chief360.
